All of our services are provided free of charge to cancer patients, thier families and our community.

4a (Code:) (Expenses \$ 1,745,093 including grants of \$) (Revenue \$) Hope Cancer Resources helps ease the financial burden brought on by cancer by providing financial assistance in paying a patient's everyday living expenses (utility bills, mortgage or rent payments, car payemtns, and such), providing prescription assistance and providing gas cards to help with getting back and forth to treatments. In addition, emotional assistance is provided by our staff of licensed social workers, including one-on-one assessments to identify needs, counseling, and patient navigation. All of our services are provided free of charge.

4b (Code:) (Expenses \$ 259,869 including grants of \$) (Revenue \$) Hope Cancer Resources provides cancer prevention education programs in area schools, to civic groups, human services agencies and in other community venues. We also employ tobacco treatment specialists engaged in tobacco cessation programs on an individual and group basis. In addition, the Wellness Center for Hope promotes wellness and healthy living in cancer survivors and caregivers by offering individualized exercise programs for survivors. Our objective with these programs is to help create a healthier Northwest Arkansas. All our services are provdied free of charge.

4c (Code:) (Expenses \$ 720,424 including grants of \$) (Revenue \$) Hope Cancer Resources provides free transportation to patients who have no other way to get to their treatments or to relieve the burden on family and friends. In 2023 we drove our 8 vehicles 312,112 miles transporting 384 patients on 7,610 trips. All our services are provided free of charge.
